To provide our services, we collect the following information from clients:

Personal contact information:

Transaction information:

- Order number, service tier selected, payment confirmation (processed by Stripe — Winners Pathway does not store card details)

3 — HOW WE USE YOUR INFORMATION

Your information is used solely for the following purposes:

- Communicating with you about your order, revisions, and delivery
- Running ATS validation and quality checks on your documents
- Maintaining internal records of completed orders
- Complying with legal obligations

We do not use your information for marketing, profiling, or any purpose unrelated to your order.
